

In connection with the entry into force of the Regulation of the European Parliament and the EU Council on the protection of individuals with regard to the processing of personal data and on the free flow of such data (GDPR) of 27-04-2016 and the increasing value of information and especially personal data, Plastwil Sp. z o. o. is aware of the importance of threats related to the process of data processing and declares taking systematic actions to prevent threats to information security, the occurrence of which may lead to loss of confidentiality, data integrity and accountability, and in particular to unauthorised access to such information, as well as its' damage or destruction.

To guarantee the above declaration, the Company strives to achieve a satisfactory level of security of the processed information by:

- Confirming the need to protect information, with a particular emphasis on data processed in information systems.
- Providing support for information security initiatives.
- Providing the resources needed to implement the required security.
- Introducing special supervision for all documentation containing customers' personal data.
- Implementing actions to raise awareness of employees/collaborators regarding the validity and importance of the data being processed, including personal data.

At the same time, we inform that:

- I. According to art. 13 paras 1 and 2 of the General Data Protection Regulation of 27 April 2016 (Journal of Laws L 119/1, 4/05/2016), **the administrator of ADO** and the recipient of your personal data is Plastwil Sp. z o. o. ul. Wierzbowa 2, 64-850 Ujście, including employees.
- II. Your personal data will be processed in order to:
  - provide information about the current offer
  - send information regarding promotions
  - run other marketing activities regarding products offered by Plastwil Sp. z o. o.
- III. At any time, you have the right to access your personal data, as well as the right to their rectification, deletion, restriction of their processing, the right to transfer data, the right to raise objections and the right to withdraw prior consent to the processing of personal data. The consent withdrawn at any time does not affect the compliance of the data processing with the law that was made under this consent prior to its withdrawal.
- IV. You have the right to submit a complaint to the supervisory body when you conclude that the processing of your personal data within the scope of this consent violates the provisions of the General Data Protection Regulation of April 27, 2016 (Journal of Laws No. 119/1, 4/05/2016)
- V. Your personal data will be transferred to other processors to whom Plastwil Sp. z o.o., is obliged, as part of running a business, to give you personal information contained in sales documents as part of the implementation of orders.
- VI. Your personal data will not be transferred to a third country/international organisation.
- VII. Personal data will be processed until the withdrawal of consent for the processing of your personal data or for another period regulated by law, where applicable.
- VIII.
